6. To consider, and if thought fit, to pass an ordinary resolution approving the Company's restricted share unit plan, as amended, as more particularly described in the Information Circular accompanying this Notice.
7. to transact any other business which may properly come before the Meeting, or any adjournment or postponement thereof.
